



## INTRODUCTION

RUDO Consulting is accredited by the ETDP SETA to provide an accredited Assessor training. The purpose of the Accreditation and Training Services' generic Assessor training course is to equip learners with the required knowledge and skills to assess candidates in their specific field of expertise. The Assessor training course will help build your understanding of the National Qualifications Framework (NQF) and will help you take the first step in developing your skills and acquiring a variety of qualifications within the fields of Education Training and Development Practices and Human Resource Development.

Upon completion of the training candidates are expected to complete PoEs which will be assessed and moderated by a qualified assessor and moderator. Then the PoEs will be externally moderated by the ETDP SETA during the verification process and moderated by a qualified ETDP SETA ETQA staff. It is only then the candidate will be declared competent or not yet competent. Then if the candidates meet a high standard of criteria he can be registered as an assessor and be allowed to conduct outcome-based assessments.

## IMPORTANT

- This is a five- day training programme starting at 9h00 until 15h00.
- The first four days are for Tuition, Formative Assessment and Compilation of POE. The last part of the fourth day is for commencement of Summative Assessment and POE
- The fifth day is for completion of Summative Assessment and finalization of POE.
- Candidates are expected to develop their PoEs during the four days of training.
- The PoEs will be handed over to the facilitator on the fifth day of training no exceptions.
- Each candidate attending training needs to enrol and complete the enrolment form below. The enrolment form is to be accompanied by a:
  - **CERTIFIED copy of an ID.**
  - **Copy of highest qualification**
  - **Copy of CV**

**These will be submitted to ETDP SETA** to be loaded on the learner portal.

- Once the learner is admitted they will be registered in the ETDP ETQA system.
